#### **Old Business**

Chairman Hord ask if there were updates to the ESRB safety pamphlet. Mr. Hord requested the pamphlet to include current restrictions of non-licensed elevator workers entering hoist ways. DOL web content creator Danielle Anderson would like input, suggestions from board members regarding content.

#### **New Business**

- 1.) Member Jason Danker suggested to the Department of Labor the creation of 'Smart Codes 'to be publically posted in all elevator cabs.
- 2.) Member Jason Danker requested the creation of a standard code regulating elevator movement & weight changes, when a unit is being serviced. Mr. Danker suggested the forming of an ad-hoc committee to develop the code, in consideration for safety of a unit, when being serviced. Mr. Danker requested input from member Charles Meeks to be considered before the code is finalized. Member Charles Meeks informed board members Elevator codes are currently enforced by Electrical Inspectors. Matt Helminiak informed a memo of suggestion could not enforce a safety regulation. DOL staff member Ralph Dillman reminded the board only an active code can be enforced. Mr. Dillman noted regulation 171 currently addresses weight changes, car blocking and clearances. A safety concern memo can be created and submitted to the O&P Commissioner for review. Chairman Hord request the ad-hoc committee format the memo to included references regarding weight changes, car breaks and clearance space. Chairman Hord request Ralph Dillman review the final draft, before submission to the O&P Commissioner.
- 3.) Member Jason Danker requested steel grating access made available to Elevator Mechanics and Elevator Inspectors, noting currently, there are no designated general work spaces.
- 4.) DOL staff member Ralph Dillman request board member Charles Meeks provide him with active stats on clearance fatalities.
- 5.) Board member Jason Danker made an inquiry when electronic / online applications will be available. DOL staff member Lakissha Thornton shared that there no updates at this time.
